

●● AMISH COUNTRY SWEEPSTAKES OFFICIAL RULES ●●

1. **HOW TO ENTER: NO PURCHASE NECESSARY.** To enter, complete the online form at <http://waterbrookmultnomah.com/bookcontests/> You must be a legal resident of the 50 United States and the District of Columbia and 25 years of age or older to be eligible. All federal, state and local regulations apply. Void where prohibited.
