

KIM VOGEL SAWYER BED & BREAKFAST SWEEPSTAKES
●● OFFICIAL RULES ●●

IMPORTANT: Please read these Official Rules before entering the “*Kim Vogel Sawyer Bed & Breakfast Sweepstakes*” (the “The Sweepstakes”), presented by The WaterBrook Multnomah Publishing Group, an imprint of The Crown Publishing Group, a division of Random House LLC (“Sponsor”). Entrants may submit up to three (3) eligible entries by completing the following steps listed below. One or more of the below entries must be completed to enter the Sweepstakes:

- a) Within the Sweepstakes widget a) click on the +2 “Tweet About the Giveaway” button; b) tweet about the sweepstakes; and c) submit the URL of your tweet in the Sweepstakes widget where prompted. All steps must be complete for an entry to be considered eligible.
